

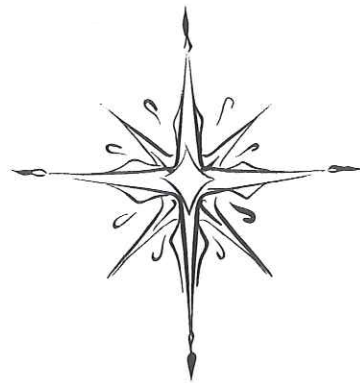

# Mother's Day Out Policies and Registration Form

## Our Ministry and Our Mission

This Mother's Day Out program is organized and operated as a part of the total ministry of Parkway Baptist Church. The tuition and fees support the salaries of the teachers and the operating expenses of the program.

Our staff has a deep concern for the total development of each child and the well being of the family of each child. Well trained and dedicated teachers, enthusiastic and cooperative parents, and the committed support of Parkway Baptist Church are the necessary ingredients for our outstanding program.

Our Mission is to provide a safe, caring environment for your 1 year through 4 year old that will allow the child's primary caregiver a much needed time out. It is our desire to provide a constructive and meaningful program for young children under the guidance of trained personnel in a Christian environment and to promote emotional, social, physical, intellectual and spiritual growth of each child.



## Registration and Fees

In order to be enrolled in this MDO program a completed registration form must be submitted with the appropriate fees to the Children's Minister. A registration form is attached or you may call the church office.

Fees are as follows:

Registration: \$25 (must accompany completed enrollment form.)

Tuition: \$115 per month for 2 days a week -- \$55 per month for 1 day a week.

Supply Fee—\$35 due in September and \$35 due in January.

Children ages 1 year (by September 1st) thru 4 years are eligible for registration.

Our program will begin the first Tuesday after Labor Day and then follow the Clinton Public School District calendar for holidays and closings.

## Health Policies



"...I was sick and you looked after me..."  
Matthew 25:36

- ◆ Children who do not feel well should be kept at home, even if symptoms of illness are not yet present.
- ◆ Your child should be free of fever, vomiting and diarrhea for 24 hrs before attending MDO.
- ◆ If your child is taking medication but is no longer contagious it is acceptable to bring them as long as there are no side effects from the medication such as vomiting or diarrhea.

## Discipline

All staff for Mother's Day Out will have demonstrated a loving spirit, good judgment and self-control in working with children. They will all relate to children with respect, acceptance, and patience. No harsh words or corporal punishment

will be used in discipline; only positive praise and if necessary, a brief "time out". If any child shows excessive disturbances or undesirable behavior, we will contact the parents and ask for assistance.

## Arrival and Pick-Up

Children should arrive no earlier than 8:50 a.m. and should be picked up no later than 2:10 p.m. A late fee of \$5 for the first 10 minutes will apply and then \$1 per minute after 2:20 p.m.

Children should be picked up at their classroom so that the teacher can share any information necessary with the parent. Children will only be released to individuals authorized on the registration form. Children will not be allowed to leave with any other person without



- ◆ No medications will be dispensed by teachers or caregivers.
- ◆ Please keep your child home if any of these symptoms are evident:
  - \*Green or yellow discharge from nose or ears
  - \*sore throat
  - \*unexplained rash
  - \*pink eye or other eye infections
  - \*common cold—from onset through 1 week

You are required to provide a healthy lunch for your child each day. Please avoid sweets and send containers that are easy for your child to open. Please do not send any glass containers or carbonated sodas.

For infants, please provide plastic bottles, spoons, bibs and feeding instructions.

All items should be labeled.
